GRATIS VISA

Afghanistan, Argentina (only **Business, Tourist & Transit Visas** on gratis basis to nationals of Argentina. Normal visas fee is applicable for all other type of visas), **Bangladesh, DPR Korea, Jamaica, Maldives, Mauritius, Mongolia, South Africa, Uruguay** (only **Tourist Visa** on gratis basis for Uruguay nationals and normal visa fee is applicable for all other type of visas) and **Seychelles** (**All types of visas, except Employment/ Work visa**)

Nationals of Nepal and Bhutan do not require visa to enter India. However, Nepali nationals require visa if they enter India from China, which is gratis.

Visa fees for **Pakistani nationals** : Rs. 100/- @ USD1.073 = Ar. 17,000/- (inclusive of ICWF Fee i.e. Ar.12500/-)- **All types of visas**
